

# **NBCE:** National Board of Chiropractic Examiners

- Licensing Board for all Chiropractors in the United States
- Consists of 4 Parts.
- Must pass the prior exam before taking the next
- Each State has it's own requirements
- Must graduate from accredited University
- Optional: Physiotherapy and Acupuncture



#### Part I

- Examination in: 6 basic science areas: general anatomy, spinal anatomy, physiology, chemistry, pathology, and microbiology
- Each subject has 110 standard questions
- Test is 90 minutes long per science area.



#### Part II

- 6 Clinical Science areas
- 110 questions each
- General diagnosis, diagnostic imaging, principles of chiropractic, chiropractic practice, and associated clinical sciences
- Each section is allotted 90 minutes testing time with 20 minute break in between



#### Part III

- Addresses 9 Clinical areas: case history, physical examination, neuro-musculoskeletal examination, diagnostic imaging, clinical laboratory and special studies, diagnosis or clinical impression, chiropractic techniques, supportive interventions, and case management.
- Consists of two books: 110 questions and 10 case vignettes
  - Each book has 55 questions, plus 5 case vignettes
  - Each of the 5 case vignettes contain 3 extended questions
  - Each extended question requires 3 answers
  - Each book is allotted 2 hours of testing time



#### **Part IV**

- Administered twice a year at chiropractic college test sites throughout the US
- One general passing score accepted for each State
- Three major areas of testing
  - X ray interpretation and diagnosis
  - Chiropractic technique
  - Case management



## Part IV: Diagnostic Imaging

- Consists of 10 Stations: 4 minutes per station
- Each station will have diagnostic studies and other case history for review
- Each station has 2 extended questions with each question having 10 answer choices
- The examinee will be required to select two of the most correct choices
- Imaging may be: X ray, MRI, CT, Radionuclide bone scan, or diagnostic ultrasound



## **Part IV: Chiropractic Technique**

- Five stations with five minutes per station
- The examinee will be given a written description of two vertebral or extremity subluxations: includes two chiropractic techniques to include proper patient positioning, segmental contact point, doctor hand positioning
- The examinee will place the patient in proper position and demonstrate proficiency
- Examinee will also be required to static and motion palpate the patient to determine certain bony landmarks and/or normal joint movement



## Part IV: Case Management

- 20 Stations: 5 minutes per station
- At each station the examinee will be required to:
  - Perform a brief (focused) case history
  - Perform a brief (focused) physical examination
  - Perform a brief (focused) orthopedic/neurological examination
  - Choose the most likely diagnoses and/or clinical impressions
  - Choose the most appropriate case management procedures
  - Choose the neurological signs most likely to be present
  - Choose the most appropriate orthopedic/neurological tests to perform



### Part IV: Case Management continued

- Examinee will perform these test on patients who are trained to simulate a specific condition
- Examinee will be evaluated on their clinical skills as well as their ability to communicate with the patient
- Examinees will be evaluated on their ability to fully explore the parameters of the
  patient's condition to elicit specific clinically relevant elements of the history from the
  patient
- There will also be a verbal component in which the examinee will be required to explain their line of thinking and rationale to the examiner
- At the post encounter station that immediately follow the simulated patient stations, the examinee will be required to answer two questions related to the condition exhibited by the patient
- This is a time sensitive test with 5 minute allotted to complete the required task at each station
- Success in this examination will depend on the examinee's efficient and skillful performance of the required tasks, as well as on the effective use of the allotted time



## **Optional Examinations:**

#### • Acupuncture:

- An elective examination that consists of 200 standard questions
- Examination divided into 2 books (100 questions each)
- Each book is allotted 90 minutes each

#### Physiotherapy:

- An elective examination that consists of 92 standard questions and 2 case vignettes
- Each case vignette contains 3 extended questions
- Each extended question requires 3 answers
- Allotted 90 minutes of time to complete the examination
