Quarantine/isolation subjects compensation for epidemic prevention

Persons Eligible for application must fulfil all of the followings :

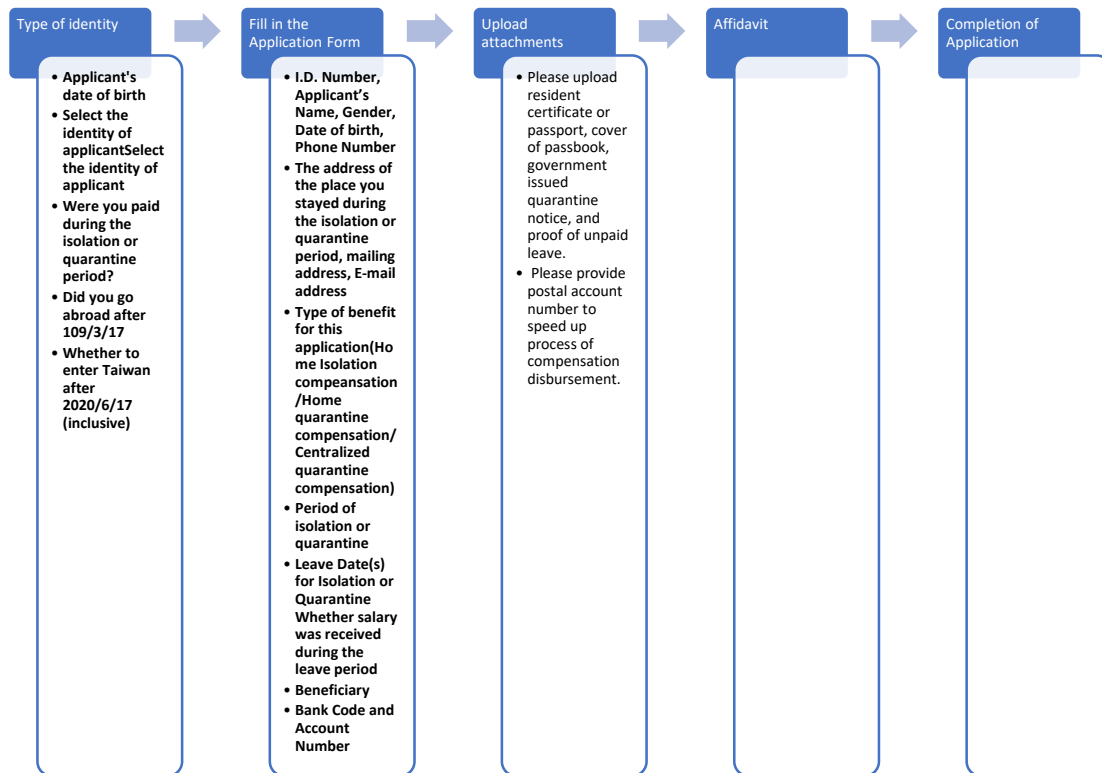
- Submission of applications must be made in person with exception of minors under the age of 20 whose application can be made by parents, legal guardians or legal representative.
- Have Home (Self) isolation/ Quarantine notice
- Upon completion of 14 days of home (self) isolation or quarantine
- No violations of the Home (Self) Isolation Regulations during period of isolation or quarantine
- Had not received any form of salary/ payment during period of quarantine
- DID NOT travel to countries or territories with Level 3 travel notice unnecessarily since 2020/03/17
- HAD NOT given incorrect information on the COVID-19 Health Declaration Card, such as incorrect contact information or with missing information
- Starting from June 17, 2020 (the date of entry), " National Identification Card(Taiwan) holders " or " Resident certificate for the Taiwan area " may apply for epidemic prevention compensation. Non-native nationals without a residence permit, people from the Mainland China, residents of Hong Kong or Macau "may not" request for epidemic prevention compensation.
- Those who are quarantined or quarantined under the " National Identification Card(Taiwan) holders " or " Resident certificate for the Taiwan area " or who are quarantined or quarantined who cannot take care of themselves must still abide by the epidemic prevention regulations. Those who have not violated the epidemic prevention measures implemented by the Central Epidemic Command Center, have not paid salaries, and have not received subsidies of the same nature as required by other laws and regulations, are eligible to apply for epidemic prevention compensation.

Before application, you should prepare the following documents

1. National Identity Card (Prepare Health ID card or Household Certificate for minors)
2. Applicant's passbook (For minors, please provide passbook of minor's parent, legal guardian or legal representative)
3. Letter of proof of leave and no salary for those who are employed by companies

or corporates. Please download the template form and ask your employer to complete the form.

4. Affidavit for those who are self-employed or without a certain employer. The system supports online signature, please sign with computer mouse or directly on touch panel.
5. If you are under the age of 20, please download and attain authorized signature for the form of Agreement from Legal Representative.

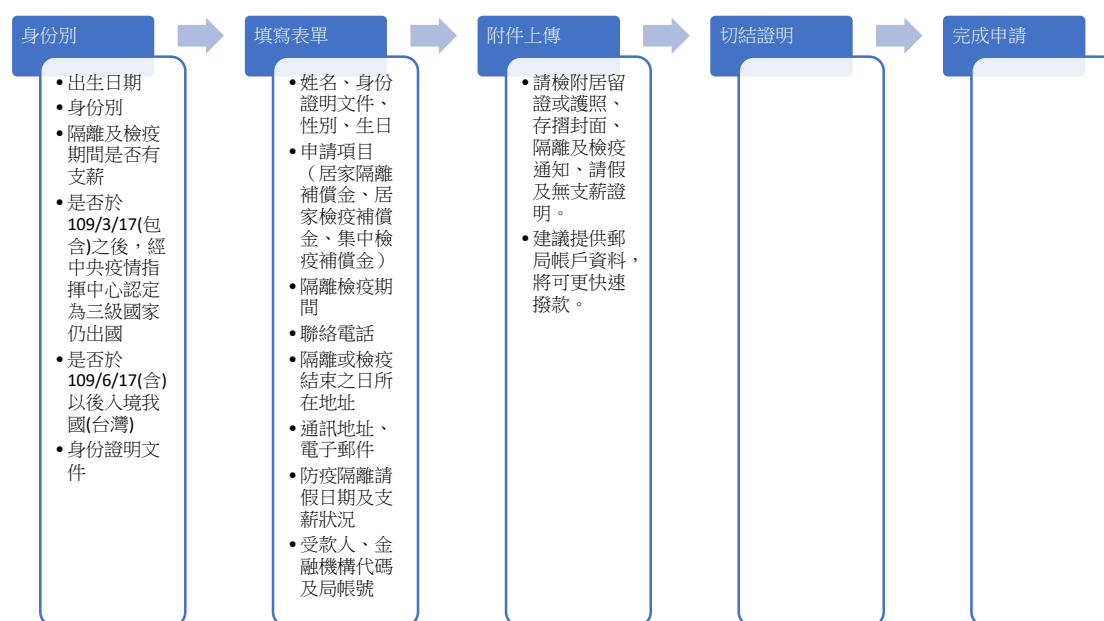

 - 109年3月17日後如有非必要出國情形，則不得請領防疫補償。
 - 109年12月1日起若旅客無法出示3日內核酸檢驗報告，則不得請領防疫補償(符合上述4類對象則不適用)
1. 緊急協處
 2. 來自無法自費篩檢國家
 3. 經指揮中心同意
 4. 其他指揮中心公告對象
- 自109年月17日起(入境日)，「國人」或「持居留證者」得請領防疫補償。「無居留證」之非本國籍人士、大陸地區人民、香港或澳門居民「不得」請領防疫補償。

準備文件

1. 申請書
2. 申請人之國民身分證正反面(非本國籍人為居留證或護照)。
3. 受隔離或檢疫者之金融帳戶存摺封面影本(倘為未成年人或受監護宣告者，得檢附法定代理人或監護人之金融帳戶存摺封面影本)。(請使用非靜止戶帳號。公教戶、凍結戶、警示戶、結清戶、外幣帳戶、公司行號帳戶，不可使用，否則將無法完成匯款)
4. 請假及無支薪證明(若您受雇於公司或企業者)(請先下載證明，並請公司先行開立)
5. 切結書(若您為自營作業者、無一定雇主者)，系統支援線上簽名，請用滑鼠或手指進行簽名。若您為未滿20歲之未成年人(請先下載法定代理人同意書，並請先行簽名)
